### **Election of FGE Board Members**



Section 2.12 of the Forest Glade Estates CC&Rs states "At each annual meeting the members shall elect five directors for a term of one year; directors shall serve concurrently. **Cumulative voting** is permitted for the election."

Section 5.1 of the FGE Bylaws further states "Nomination for election to the Board of Directors shall be made by a Nominating Committee.

This year's Nominating Committee consists of Jean Shuler-Chairman and Peter & Kristy Haugen as committee members. After working feverishly for a month they have arrived at an official list of election candidates.

### **Voting Process**



Election ballots have been prepared and distributed 2 weeks before the Annual Meeting. Please follow the instructions on the ballot and place only 5 check marks on your ballot. Completed ballots

should be returned to their numbered envelopes, sealed, and delivered to any board member before the Annual Meeting (or brought to the meeting). The ballot counting will occur at the Annual Meeting by disinterested volunteers and the results reported forthwith.

The elected board members subsequently elect officers (president, vice-president, secretary, and treasurer) during their first board meeting.

### **FGE Bylaws Review**



The FGE Board has recommended that our Bylaws and CC&Rs should be reviewed and edited to bring them up to date. They were originally written in 1978.

The Bylaws Review Committee will consist of Tim Barry; Irv Stowers; Tim Horgan;

Peter Haugen & Kristy Haugen. The committee has yet to find a common date for the first meeting.

The charter of this committee is to "review the Bylaws with the intent of clarifying some misunderstandings, suggest changes to the date of the annual meeting, and address the current election process (the cumulative voting process) so as to simplify it consistent with the CC&R." The committee's charter is also to "establish a calendar of due dates for the election of Directors, Annual Meetings, distribution of homeowner's bills, and collection due dates."

She went on to earn a Ph.D. in Chemistry from the California Institute of Technology in 1986.

Laura is survived by her husband Alan Sylwester and two daughters Lauren and Rachel Sylwester.
