Bylaws & CC&Rs Election Results

The recent vote tally on Saturday, December 19th. demonstrated an excellent neighborhood turnout with 67 of homeowners 69 submitting ballots. However, the results showed that the members did not support either the proposed Bylaws (For: 31, Against: 36) or CC&Rs (For: 27, Against: 40). One of the Board's priorities for the new year is to address the original, outdated governing documents with the active participation and inclusion of all our FGE homeowners.

Election Rules Revision Committee Formed

The recent elections have identified some gaps in our current election rules. A committee was formed at the December Board meeting to propose procedures conducting recounts, resolving tie votes, and other such issues. Members are McMichael Larry (chair).
